POPCORN PARK LOCATED AT OUR AHS-LACEY FACILITY WAS ESTABLISHED IN 1977 FOR THE SOLE PURPOSE OF PROVIDING A REFUGE TO SICK, INJURED, PERMANENTLY DISABLED, ABANDONED, ELDERLY, AND UN-RELEASABLE WILDLIFE, FARM ANIMALS, AND EXOTIC ANIMALS THAT WOULD BE UNABLE TO SURVIVE ON THEIR OWN.
